Dear Valued Vendor

Sub.: Value Added Tax (Tax)

As you may be aware, Value Added Tax [VAT] will be introduced in the United Arab Emirates, with effect from 01 January 2018. Going forward, we expect your support to comply with requirements of UAE VAT laws and regualtions. Therefore, kindly provide the VAT registration number [TRN] in order to ensure the payment on time in an accurate manner.

Please note that we will settle the payments against valid **VAT invoice only** [where it is properly certified and due].

VAT Invoice

We appreciate, if you could provide the invoices with the following details, this will useful to meet the necessary requirements:

- 1. The name, address and VAT Registrations Number of the supplier
- 2. The name, address and VAT Registration Number of Interiors International Industries LLC [Copy of our VAT registration certificate is enclosed for your reference]
- 3. A sequential unique Tax invoice.
- 4. The date of issue of the Tax invoice.
- 5. The date of supply [only if different from the invoice date]. [Where multiple supply dates are applicable the last date of supply to be mentioned].
- 6. A description of the goods and /or services supplied and /or subcontractors work done.
- 7. For each description, the quantity or volume of the goods or services supplied and/or subcontractors work done, the rate of VAT and amount payable, expressed in local currency.
- 8. The unit price of supply where it should break down into units otherwise the total VAT exclusive price.
- 9. The amount of any discount offered.
- 10. The gross amount payable expressed in local currency.
- 11. The place of supply should be indicated in invoice.
- 12. The VAT amount payable expressed in local currency together with the rate of any exchange applied and the source of that exchange rate applied.
- 13. Where the invoices relate to a supply under which the recipient is required to account for VAT, a statement that the recipient is required to account for VAT and reference to the relevant provision of the UAEVAT law.
- 14. Tax invoices must be issued by any registered person who makes taxable supply and this is MANDATORY!



Subcontractors

- Step 1 Submit your application for payment in accordance with the timetable established under your subcontract order. This application should exclude VAT and is not to be issued as a taxable invoice.
- Step 2 Interiors International Industries LLC will provide written approval of this application, which may be in the form of a payment certificate.
- Step 3 Upon receipt of such written approval, each vendor is to raise its corresponding VAT (tax) invoice. Payment shall only be made against the same.

Payment shall only be made against valid VAT (tax) invoices.
